#### From the Recorder

Please mark your calendars today for these events.

Nobles, we have three standard items of business to be addressed at each December Divan meeting: the election of officers and the installation of those officers, along with the approval of the Temple budget for calendar year 2023.

- 1. On December 10th, 2022, the Korein Shrine Divan Meeting will be held at 10:00 A.M. at the Temple in Rawlins. The Annual Temple meeting will follow at 11:00 A.M. The main items of business of the Temple meeting are the election of officers for the upcoming year and the approval of the 2022 Potentate's budget.
- 2. In accordance with Imperial Shrine by laws all the Nobles of Korein Shrine are hereby put on notice of the following provisions:

At the Imperial Session in July 2011 in Denver Article 25 was adopted by the voting delegates. This article deals with Officers and their election or appointment and § 325.11 Election Regulations was amended. In accordance with Imperial Shrine by laws all the Nobles of Korein Shrine are hereby put on notice of the following provisions:

§ 325.11 Election Regulations.

- Electioneering. A candidate for an elected office in a Shrine temple may print, publish and circulate during the year he is seeking elected office, a resume consisting of his educational background, his vocational history, and his Masonic and Shrine record. Except as provided in the prior sentence, the printing, publication, circulating or distribution of resolutions, letters, telegrams, tickets, email or other devices, by a unit, club, Noble or group of Nobles, suggesting, recommending, opposing, or containing the names of proposed candidates for office in the temple is prohibited.
- (b) Expenditures Prohibited. The expenditure of money for gifts, favors, or entertainment on behalf of a candidate for elected office is prohibited.
- (c) Violation For any violation of (a) or (b), the Imperial Potentate may suspend any offending Noble, and he may declare the election of officers void and order a new election.
- (d) Notice at least one week prior to the annual meeting or any election, the Temple Recorder shall mail to each member a notice thereof containing this section.
- 3. This current edition of the Klarion which is mailed or emailed to every member of

Korein Temple serves the purpose of the above notification requirement.

The Installation of Officers will happen at the Temple on Saturday, January 7th, 2023. Details for the day are available on page 6 of this publication. Hope to see everyone there.

Dues notices went out in August and that is the norm now. That was done by Tampa at the request of a lot of Shriners to allow us to avoid the end of year rush of both the Holiday Season and the various Masonic bodies most of us are members of. Virtually ALL of those bodies demand payment by the end of December to stay current.

This does not mean you have to actually pay your dues any earlier. It merely gives you the option of doing so.

#### **Korein Temple Hospital Representative Report**

Greetings Nobles, Ladies and Friends of Shriners Childrens – Salt Lake City!

Here's to a wonderful Wyoming fall and a joyous Holiday Season for all! Thank you all for everything you do for Shriners and Masonry in general.

At Shriners Childrens -Salt Lake City we continue to work through the transition from an inpatient hospital to an ambulatory care facility. focus is on those things we do better than anyone wheelchair and seating, prosthetics and orthopedics, motion analysis, a full array of therapy services and multidisciplinary clinics. We are settling into the transfer of our surgical services to our partner, Primary Childrens Hospital, our doctors having performed 40 surgeries last month and over 600 since the transition. Our doctors are looking forward to the conversion of our medical records system in the first quarter of next year, to a product that will better interface with PCH's system. Year to date we are operating at 19.8% under budget (\$1,529,227) despite logging over 7,750 patient encounters. While on the surface this seems like a good thing, the downside is we are operating understaffed due to the extremely tight labor market in health care. During our recent board of governors meeting in October, our new Clinic Manager informed us that she is having some success in filling many of those positions.

Also, during our meeting, we received the last report from Kevin Martin, our Hospital Administrator for the past 24 years! With the transition in our operating model, Kevin took the opportunity to retire after having fulfilled 36 years of service to Shriners; first as head of nursing then as administrator! Kevin has been a solid, forward thinking and positive leader for our operation! He set us on the course to make the transition to an outpatient facility, which was inevitable due to changes in the industry, and made the difficult changes with the least amount of adversity possible. Kevin was an amazing mentor for yours truly as I moved into the role of chairman! He is a good man, and he will be missed. That said, he is deserving of a wonderful retirement and some peace and quiet in his life! Our new Clinic Manager Natalie Raleigh has hit the ground running and is well equipped to take on the role she has been promoted to.

Looking forward: we are working to expand our partner-

ship with PCH that may include repurposing some of our inpatient space and the expansion of much needed service within our respective catchment areas! Decisions are under consideration with the Joint Boards this week so, I hope to give you more information in the near future.

Of concern to me is, I have heard reports of some of our patients receiving bills for services! Please, if you hear of this situation, have the parents contact me directly. Ideally, if I could have a copy of the bill, I can get it dealt with immediately. Our mission has not changed and our pledge to provide services regardless of the family's ability to pay is as important now as it ever has been.

Once again, thank you all for your continued support of Shriners Childrens! Thank you also for allowing me to service in this job! My term as Chairman will end this year; however, I still have two years left on my current term as your representative. I pledge to continue to work to make Shriners Childrens – Salt Lake City a premier facility in the Shrine system.

This year Noble Burke was able to get that sorted out; the units are now responsible for reimbursing Korein Temple for their share. If you are not sure that your unit is insured, please contact us. You have to have insurance to operate a Shrine vehicle or your own vehicle in a Shrine parade. There are no exceptions.

We leave lots of unfin-

ished business on the agenda as all that have gone before me have not been able to get it all done either. It seems that a year does not give you enough time to do it all.

There are rumors around about the sale of the building in Rawlins. As of today, they are still rumors. We have a verbal offer to buy the building. We have nothing in writing. We have an attorney presently working on clearing up the mess of the titles to the property in Rawlins and getting them recorded properly with the state of Wyoming, Carbon County and city of Rawlins.

There was agreement on sharing expenses reached in 1986 with the sale of the build-

ing to the Temple by all users. I have had no success in convincing the other parties involved to come to the table to equitably resolve our current situation. I regret that.

I hope that I did not miss anyone in thanking them. You all have a special place in my heart and have made an impact on my life.

Lady Charlyn and I offer best wishes to Noble Keith and Lady Jan next year as they assume the leadership of our Temple.
